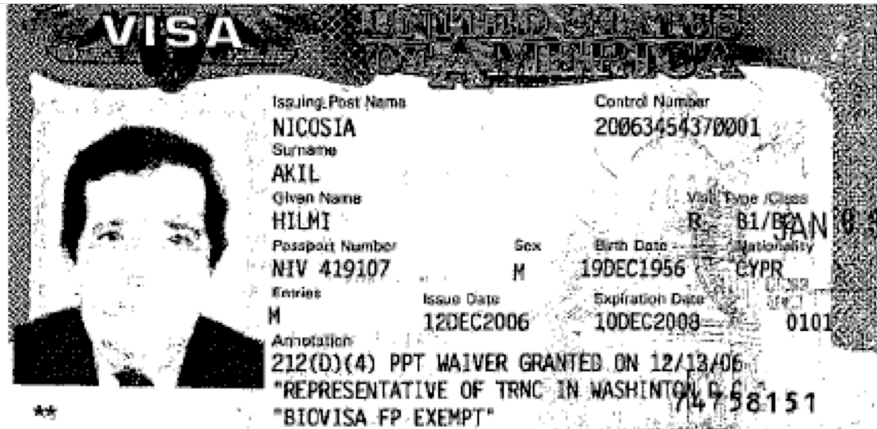




THE "TRNC" IS AN ILLEGAL COMMERCIAL ENTERPRISE AND NOT A GOVERNMENT
